### My Rights in my Out of School Club



Did you know that all children have rights which are protected by law? Children's rights are a list of the things you need to grow up feeling happy, healthy and safe. **The United Nations Convention on the Rights of the Child (UNCRC)** has articles that set out these rights. For more information please scan the QR code.

#### In my club, I can/will:

- Have my identity respected.
- Have pride in my nationality.
- Have opportunity to explore my culture and identity in different ways.
- Be free to share my family values.
- Feel safe and welcomed.

#### Other ways my club can support my right:

- Recognise my right to an identity and promote individuality.
- Promote my community and family values.
- Support and safeguard me and my parents/carers.
- Promote and support diversity.

#### Playworkers can support this children's right by:

- Calling me by my preferred name.
- Understanding my culture and heritage.
- Promoting my culture and heritage.
- Promoting a sense of community and belonging at the setting.
- Promoting and celebrating individuality.



### Guidance for Playworkers

- Watch the videos about Children's Rights with the children, on the Children's Commissioner for Wales website (QR code above).
- Talk with children.
- Consider the examples in the boxes above of how children's rights can be supported in Out of School Clubs and allow them to add their own ideas in the boxes. You could try other participation methods to gain their thoughts - [click here for ideas](#).

**General Comments** strengthen each Article (right), raising its importance and increasing accountability among countries that have signed up to the Convention. Those linked to this Article are:

**General comment 12** (2009): The right of the child to be heard.

**General Comment 11** (2009): The Committee on the Rights of the Child (CRC) adopted a General Comment (GC) on indigenous children and their rights under the CRC. The eleventh GC is addressing the issues affecting these children who "continue to experience serious discrimination in a range of areas", including access to health care and education.
