### Camp Fantastic

is a limited company and provider based within England, setting up a Holiday Club in Wales. They have a unique approach to Holiday Camps, providing childcare and free play opportunities as well as structured activities through the school holidays. With the ongoing support of Childcare Business Development Officers in South East Wales, they were able to pilot a holiday club in the summer, whilst working towards registration with Care Inspectorate Wales (CIW) achieved in time for the October half term holiday 2024.

The tailored support provided by Clybiau Plant Cymru Kid’s Clubs has been possible through their National Lottery funded project ‘Connected Childcare Communities’ enabling the club to become registered with Care Inspectorate Wales (CIW) and with HMRC to enable parents to access Tax Free Childcare (TFC) and the Childcare Offer in Wales (TCO).

“One of our founders (Lauren Whiting) is Welsh and her immediate and extended family remain in the Malpas area, which gives us a deep connection to the local community. We are excited to bring our unique approach to this region, offering a space that celebrates both local culture and our broader mission. It's about creating an inclusive, family-oriented environment where people can experience something special while building long-lasting memories. We have been truly impressed by how welcoming and supportive the local community has been as well as the school we are working in partnership with. It's been a pleasure working with people who are passionate about fostering community and connection, which aligns perfectly with our organisation's values.

Clybiau Plant Cymru Kids’ Clubs have been an invaluable partner in helping us establish our holiday camp. Their advice and guidance has been instrumental from the very beginning, offering expert insights that shaped our approach. The site visit was especially helpful, as this provided practical, on-the-ground advice tailored to our needs. As our first full-scale, non-pilot camp, we were thrilled to accept childcare vouchers and utilise the 30-hour free childcare scheme—making our services even more accessible to families. ### Camp Fantastic

Mae Camp Fantastic yn gwmni cyfyngedig a darparwr wedi'i leoli yn Lloegr, sy'n sefydlu Clwb Gwyliau yng Nghymru. Mae ganddynt agwedd unigryw at Wersylloedd Gwyliau, gan ddarparu gofal plant a chyfleoedd chwarae am ddim yn ogystal â gweithgareddau strwythuredig trwy gydol gwyliau'r ysgol. Gyda chefnogaeth barhaus Swyddogion Datblygu Busnes Gofal Plant yn Ne Dwyrain Cymru, bu modd iddynt dreialu clwb gwyliau yn yr haf, tra'n gweithio tuag at gofrestru gydag Arolygiaeth Gofal Cymru (AGC) a gyflawnwyd mewn pryd ar gyfer gwyliau hanner tymor mis Hydref 2024.

Mae'r cymorth wedi'i deilwra a ddarperir gan Glybiau Plant Cymru wedi bod yn bosibl trwy eu prosiect 'Connected Childcare Communities' a ariannwyd gan y Loteri Genedlaethol gan alluogi'r clwb i gofrestru gydag Arolygiaeth Gofal Cymru (AGC) a CThEM i alluogi rhieni i gael mynediad i Ofal Plant Di-dreth a'r Cynnig Gofal Plant yng Nghymru.

"Mae un o'n sylfaenwyr (Lauren Whiting) yn Gymraes ac mae ei theulu agos ac estynedig yn aros yn ardal Malpas, sy'n rhoi cysylltiad dwfn i ni â'r gymuned leol. Rydym yn gyffrous i ddod â'n hagwedd unigryw i'r rhanbarth hwn, gan gynnig gwagle sy'n dathlu diwylliant lleol a'n cenhadaeth ehangach. Mae'n ymwneud â chreu amgylchedd cynhwysol sy'n canolbwyntio ar y teulu lle gall pobl brofi rhywbeth arbennig wrth adeiladu atgofion hirhoedlog. Rydym wedi cael ein plesio'n fawr gan ba mor groesawgar a chefnogol y mae'r gymuned leol wedi bod, yn ogystal â'r ysgol rydym yn gweithio mewn partneriaeth â hi. Mae wedi bod yn bleser gweithio gyda phobl sy'n angerddol am feithrin cymuned a chysylltiadau, sy'n cyd-fynd yn berffaith â gwerthoedd ein sefydliad.

Mae Clybiau Plant Cymru Kids' Clubs wedi bod yn bartner amhrisiadwy wrth ein helpu i sefydlu ein gweryll gwyliau. Mae eu cyngor a'u harweiniad wedi bod yn allweddol o'r cychwyn cyntaf, gan gynnig mewnwediadau arbenigol a luniodd ein hymagwedd. Roedd yr ymweliad safle yn arbennig o ddefnyddiol, gan fod hyn yn rhoi cyngor ymarferol, llawr-gwlad wedi'i deilwra i'n hanghenion. Sicrhodd yr adolygiad o'n polisiâu ein bod yn gwbl gyson ag arferion gorau, ac mae'r prosesau mewngofnodi rheolaidd wedi bod yn galonogol, gan roi cymorth parhaus inni wrth i ni barhau i ddatblygu."



Mae'r cydweithio hwn wedi cryfhau ein sylfaen yn wirioneddol. Roedd ein Gwersyll fis Hydref yn llwyddiant anhygoel, gan ddenu plant o ystod amrywiol o ysgolion, sy'n dyst i'w hapêl ar draws y gymuned ehangach. Uchafbwynt y gwerysll oedd croesawu'r heddlu lleol a'r frigâd dân, a fu'n ymgysylltu â'r plant ac yn helpu i feithrin cysylltiadau cadarnhaol rhyngddynt â'r gwasanaethau hanfodol hyn. Ychwanegodd eu cyfranogiad ddimensiwn cyffrous i'r profiad. Fel ein gwerysll di-beilot, graddfa-lawn cyntaf, roeddem wrth ein bodd yn derbyn talebau gofal plant a defnyddio'r cynllun gofal plant 30-awr-am-ddim—gan wneud ein gwasanaethau hyd yn oed yn fwy hygyrch i deuluoedd. Ni allem fod yn fwy hapus gyda sut y daeth popeth at ei gilydd, ac mae'r adborth wedi bod yn rhyfeddol. Ni all mis Chwefror ddod yn ddigon buan - dewch â'r antur nesaf!" (Gwersyll Fantastic Aisha).
