

Andi Pandi, Carmarthenshire: Governance and Sustainability Support

A well established, family run Day Nursery in Carmarthenshire – Andi Pandi – has been delivering high-quality childcare to its community for 21 years. Alongside its Day Nursery, the business also provides valuable Out of School Childcare through its After School and Holiday Clubs. Despite its strong foundation, recent years have brought significant challenges, including the lasting effects of the COVID-19 pandemic and personal family circumstances which impacted operations.

Recognising the need to strengthen the Sustainability and Governance of the setting, the owners reached out to Clybiau Plant Cymru Kids' Clubs for guidance and support.

“Looking back at our structure of the business Andrea has been very generous, accommodating and flexible towards families and their individual circumstances.” – reflected Ellie, who recently re- joined the business. “While this reflects our ethos, it’s placed financial strain on the business – especially when we’re waiting for payments for childcare that has already been delivered, while staff wages and other costs have already gone out.” (Ellie, Andi Pandi)

Together with Childcare Business Development Officers (CBDO) from Clybiau Plant Cymru Kids' Clubs, supported the owners to review the business model and the decision was made to transition from Sole Trader to a Limited Company. This step not only increased financial security for the setting but also ensured the business could continue to run in the event of unforeseen circumstances.

“We wanted to ensure the setting could continue successfully if Andrea ever needed to step away again. Becoming Limited Company gave us that added level of protection and structure. With the right foundations, we’re hopeful for another 20+ years of providing childcare in our community.” (Ellie, Andi Pandi)

Tailored Business Support

Throughout this journey, the CBDO provided tailored, hands-on support, helping the business take clear and confident steps forward. This included:

- Face-to-face visits to offer practical advice and reassurance
- A Step-by step action plan to guide the process of becoming a limited company and re-registering with Care Inspectorate Wales (CIW) - a requirement when changing the governing model of a childcare setting.

In-depth review of the business plan and financial forecasts. Ensuring the setting could strengthen its long-term sustainability.

“Our CBDO highlighted the need for a reserves policy and helped us develop an action plan tailored to the needs of our childcare setting. Even though our accounts weren’t in a bad place, there’s always room to improve – and we welcomed the advice and guidance,” shared Ellie, Andi Pandi.

The business has also introduced new payment structures, encouraging new customers to pay in advance, and existing families to build up credit – steps which aim to help the setting transition to a more sustainable model within the next 5 months.
