

## Diddy Dragons Becoming a Charitable Incorporated Organisation (CIO)

**Diddy Dragons, based in Ysgol Acrefair, Wrexham, were supported to become a Charitable Incorporated Organisation**

After acknowledging that the club needed a more robust legal structure which included financial protection, Rebecca Turner, the Head Teacher at Ysgol Acrefair and also the Chair of the committee at Diddy Dragons, reached out to Clybiau Plant Cymru Kids' Clubs to gain support.

As Diddy Dragons was running as a Voluntary Management Committee (VMC) The Childcare Business Development Officer (CBDO) Sandra explained to the committee about their options to strengthen the committee and the benefits of a more robust legal structure, which includes the committee being financially protected. As a result, they decided to become a Charitable Incorporated Organisation (CIO)

The CBDO supported the Chairperson to recruit new committee members and once established, together they chose a model that suited them. Ongoing support enabled a constitution to be developed and the online application to register as a CIO completed to ensure they are compliant with charity law. This process can be quite daunting to complete alone.
